Sustainability and the Marine Sector

In 2019, Cabinet agreed to accede to Annex VI, subject to undertaking a National Interest Assessment. This assessment was completed in June 2020 and it was recommended that accession to Annex VI was in New Zealand's interests. It is aimed at reducing harmful ship emissions that affect the climate and public health. As part of this change the industry will need to use low sulphur fuel.
